The names of range states that were parties to the Convention as at 1 October 2007 are shown in capitalised type (e.g. ARGENTINA). If a CMS party has entered a reservation with respect to a particular species, its name is followed by an asterisk (\*) (e.g. NORWAY\*).

The list does not distinguish between different levels of occurrence. Some of the range states listed for *Numenius tenuirostris* for example, have been included on the basis of records of vagrancy rather than on established patterns of migration.

(Ex) after a country's name denotes that the country belongs to the species' historic range but species is thought to be extinct in that country.

(?) after a country's name denotes unconfirmed sightings

Where appropriate, dependant territories, overseas departments etc appear in parentheses after the name of the country responsible for them. The entry UNITED KINGDOM (Ascension Island) indicates that only part of Ascension Island and not the mainland United Kingdom is considered part of the range of the species. Conversely, the listing UNITED KINGDOM (including Ascension Island) indicates that the range of a species encompasses the UK mainland as well as Ascension Island. If the Convention does not apply to a dependent territory of a Party, the entry is shown in normal type (eg Denmark (Greenland)).

Reference to "international waters" indicates migration of a species in or above the sea or oceans beyond the limits of national jurisdiction, which falls within the substantive scope of the Convention, pursuant to Article I, paragraphs 1f) and 1h). The text in parentheses indicates the specific regions of these waters in which migration takes place.

An asterisk (\*) by the name of a **species** indicates that it, or at least one population of the species, is listed on both Appendices of the Convention
