



- X Lack of funding, human resource, institutional capacity

- X Donor goals
- X low priority

#### Conclusions and recommendations

- Strategies strong, implementation weak.
- Charismatic, powerful symbol, one of 'big 5'
- But challenging for local people to live with
- Polarisation of views on trophy hunting
- Future dialogue:
  - existing CMS/CITES meeting framework
  - Separate, specific forum
    - political buy-in
    - procurement of finances
    - strategy implementation
