EXECUTION OF THE CMS BUDGET DURING THE PERIOD JANUARY TO AUGUST 2015

Summary

This document provides an overview over the current status of assessed contributions as well as budget implementation as requested by Resolution 11.1 COP 11. It shows that overall expenditures are on track and proposes the draw-down of the Trust Fund for certain activities as well as the use of contributions of new Parties for consideration by the 44th Standing Committee Meeting.

I. Introduction

1. The present report provides the Standing Committee with an overview of the implementation of the CMS budget during the first eight months of 2015.

II. Status of the Trust Fund for Assessed Contributions as at 31 July 2015

2. As shown in Annex I, the total unpaid pledges as at 31 July 2015 amounted to EUR 915,725 (EUR 709,142 for 2015 and EUR 206,583 for 2014 and prior years). This means that out of the 2015 pledges, 68, 21 % had been received as at 31 July 2015 from 46 out of the 120 Parties to the Convention. It is therefore worth recalling that paragraph 5 of resolution 11.1 urges Parties to pay their contributions as promptly as possible, preferably not later than March in the year to which they relate.

III. New Parties in 2015 and Proposed Use of their Assessed Contributions

3. In 2015, two new Parties have joined CMS: Afghanistan and Brazil which leads to an additional EUR 364,020 EUR to the CMS Trust Fund within the current triennium as per Table 1 below:

4. The CMS Secretariat proposes to use these contributions for regional activities.

IV. Implementation of the 2015 Budget

5. COP Resolution 11.1 provided a budget (excluding Programme Support Costs of 13%) of EUR 2,102,266 for 2015. Estimated expenditures incurred during the period January to August 2015 are provided in Annex II¹. Due to the implementation of a new Enterprise Resource System in the UN Secretariat called UMOJA in June 2015 and the move to financial reporting compliant with the International Public Sector Accounting Standards (IPSAS) used internationally as opposed to the United Nations System Accounting Standards (UNSAS) previously used, expenditures are estimated and include certain prior year adjustments, especially in the staff costs, which are being verified.

¹ UNEP's official accounts are maintained in US dollars, however, for the purpose of this report, expenditures in Euros have been estimated by using an average of the monthly UN official exchange rates during the expenditure period (1 USD = 0.9083 EUR).

6. During the first eight months of 2015, an overall expenditure of 58.77% corresponding to EUR 1,235,472 is reported. The breakdown is as follows: Expenditure on staff amounted to EUR 1,033,866 against a budget of EUR 1,685,556 – an implementation rate of 61.34%. During the same period, expenditures on operating costs amounted to EUR 158,106 against a budget of EUR 279,653 – an implementation rate of 56.54%. With respect to the Servicing of Governing Bodies and the two activities foreseen in the CMS budget (the strategic plan and the study on synergies within the CMS family), the study on synergies within the CMS family has been undertaken and for the other activities, these are either in the preparatory phase or are scheduled to start later in the year. In view of the afore-mentioned, it is projected that 2015 expenditures will be within budgetary provisions. Some staff lines are likely to be overspent but can be covered by savings from other staff costs and by keeping the part-time Clerk post within Conferences and Support Services vacant financing the Deputy Executive Secretary's Secretary as well as a Secretary within the Conferences and Support Services to work 80% instead of 50%.

V. Request for use of resources from Trust Fund to be authorized by the Standing Committee

- 7. The opening balance of the triennium ending in 2014 was USD 1,406,738. In accordance with the 2014 provisional financial statements issued by UNEP, the 2014 closing balance of the CMS trust fund was USD 944,136. Considering that the Parties authorized a yearly draw-down of the reserve of EUR 130,000, there are overall savings of estimated EUR 45,026 for the last triennium.
- 8. According to Resolution 11.1 adopted by COP 11, the minimum amount of the reserve should be kept at USD 500,000. Therefore, considering the actual reserve is almost twice as much, the Secretariat proposes to allocate EUR 179,000 from the reserve for the following: EUR 107,000 to 2016 and EUR 72,000 to 2017 to cover the costs for replacing the P2 Associate Programme Officer dealing with Terrestrial Species while on maternity leave in 2016, to increase the funding for the post of the P2 Associate Information Officer in CMS from 50% to 100% in 2016 and 2017 to strengthen the capacity of the Common Information Unit and for coordination support to the Strategic Plan Working Group in 2016 and 2017.
