#### 3. Secretariat report on inter-sessional activities

<u>Expected outcome</u>: Participants are kept abreast of the latest regional developments, prospects for recruitment of new Parties, as well as future planned activities.

The discussion is expected to cover, as well, new initiatives for Agreements, Memoranda of Understanding, and project activities, as necessary.

#### 9.4 Potential resolutions/recommendations

- 9.3 Committee to note proposals submitted or under preparation, with a view to encouraging regional consultations and, where appropriate, encouraging submission of additional proposals.
- 9.4 Resolutions/recommendations tabled for consideration and further development; elaboration of list of additional issues potentially requiring COP7 decisions.

## 10. Report of the 10<sup>th</sup> Meeting of the Scientific Council and matters of the Scientific Council relating to the work of the Standing Committee

The Chairman of the Scientific Council, Dr. Colin Galbraith will summarize the results of the 10<sup>th</sup> Meeting of the Scientific Council and will highlight those issues of direct relevance to the Standing Committee, including those requiring decision by the Committee, including the appointment of a Scientific Councillor for Asiatic fauna.
