#### **ADMISSION OF OBSERVERS**

(Prepared by Secretariat of the Dugong MOU)

**Summary:** This document presents the list of Observers that registered for the Meeting by 25 March 2024. The Meeting is invited to examine the list presented with a view to admitting participation by those parties.

- 1. Paragraph 6 of the Text of the Dugong MOU states that persons or organisations technically qualified in dugong conservation and management may attend sessions of Signatory States' regular meetings.
- 2. Rule 4 of the Rules of Procedure for Meetings of Signatory States to the Dugong MOU adopted at the Third Meeting of Signatory States (MOS3, Abu Dhabi, March 2017; see Annex 1 to document <a href="CMS/Dugong/MOS3/Report">CMS/Dugong/MOS3/Report</a>\*) sets the rules for the admission of Observers to Meetings of Signatory States. Rule 4 states that agencies or bodies technically qualified in the conservation and management of dugongs and their habitats, and which have informed the Secretariat of their desire to be represented at the Meeting by Observers, shall be permitted to be represented unless at least one-third of the Signatory States present object.
