**CMS APPENDIX I-LISTED SPECIES IN INTERNATIONAL TRADE
AN ANALYSIS OF CITES TRADE DATA 2015-2018**

(Prepared by the Secretariat)

Summary:

This document contains an analysis of CITES trade data for the period 2015-2018. The analysis was undertaken by the Secretariat to inform Parties about the nature and magnitude of international trade in CMS Appendix I-listed species as requested by the 4th Sessional Committee of the Scientific Council (ScC-SC4). The analysis aims to support the discussions under agenda item 21 *Application of Article III of the Convention*.

CMS APPENDIX I-LISTED SPECIES IN INTERNATIONAL TRADE

An Analysis of CITES Trade Data 2015-2018

Background

1. Document [UNEP/CMS/COP13/Doc.21](#) *Application of Article III of the Convention* draws the attention of the Conference of the Parties to circumstances where species listed on CMS Appendix I may be the subject of international trade involving a CMS Party. Such trade may violate and/or undermine provisions of the Convention.
2. Article III (5) of the Convention prohibits Parties from taking Appendix I-listed species and defines a narrow set of exceptions to this obligation: if the taking is for scientific purposes, for the purpose of enhancing the propagation or survival of the affected species, to accommodate the needs of traditional subsistence users of such species or if extraordinary circumstances so require. Such exceptions must be precise as to content and limited in space, time and should not operate to the disadvantage of the species and shall be notified to the Secretariat.
3. The Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) is the main global instrument regulating international trade in species through listing in its Appendices. The data of the annual reports submitted by CITES Parties are entered into the CITES Trade Database.
4. At the 4th meeting of the Sessional Committee of the Scientific Council of CMS (ScC-SC4 in November 2019), the Council reviewed Document [UNEP/CMS/COP13/Doc.21](#) in order to provide its views, and requested the Secretariat to gather information about the magnitude of trade in CMS Appendix I-listed species to inform the discussion at CMS COP13 (see [UNEP/CMS/COP13/Doc.21/Add.1](#)). For that purpose, the Secretariat has examined the CITES trade data available in the online CITES trade data base for a period of the four years 2015-2018.
5. The analysis is limited to international trade in CMS Appendix-I listed species that are also included in one of the three Appendices of CITES, and for which trade data are contained in the CITES trade database. The results of the analysis are presented in this Information Document.

Summary of Findings

6. As presented in table 1 the 2015-2018 CITES trade data indicate that CMS Parties have engaged in trade across a range of species that are included in CMS Appendix I, both as importers and exporters. Traded goods range from 'live' animals, whole bodies of dead animals, body parts of dead animals (bones, carvings, trophies) or body parts taken from live animals (e.g. vicuna hair).
7. Under CMS, the taking of Appendix I-listed species is prohibited unless subject to one of the narrow exceptions included in Article III (5). For recorded transactions shown in the results of this document that involved at least one CMS Party as an importer and/or

an exporter, the Secretariat has not received notifications of any exceptions made pursuant to Article III (5).

8. The CITES trade database includes relevant information that allows for analysis of evidence on CMS Appendix I-listed species that are traded internationally by CMS Parties. However, as the data scheme was specifically developed to accommodate CITES rules and regulations, entries in the database are at times difficult to match with the requirements and exceptions under CMS Article III.
9. For instance, the country of origin of the traded specimens (or parts of a specimens) is not always indicated, which may have implications for CMS Parties, in particular regarding populations for which reservations have been submitted. In other cases, the exact source of the traded good is unclear or, in cases where species were sourced from the wild, the exact time of when this happened is not included in the data. Likewise, CITES categories for the purpose of the trade are not tailored to address the exceptions under CMS Article III (5).
10. Furthermore, information on transactions with the purpose code 'Zoo' is not sufficient to show whether these transactions fall within the exceptions of Article III (5). It may be that 'zoo' programmes are in place for reintroduction of the species if a captive breeding operation is intended.
11. Additionally, CITES definitions do not provide a clear picture as to whether transactions with a 'Medical (including biomedical research)' or 'Scientific' purpose fall within the exceptions of Article III (5). Annex 1 of this document presents trade records of 'seized or confiscated' specimens, but the information provided through the CITES database is often absent or provided in insufficient detail.
12. Finally, not all species that are included in CMS Appendix I are included in one of the CITES Appendices (e.g. the Common Guitarfish). As those species are not included in the CITES trade database, information on international trade in these species could not be gathered in the context of this analysis.
13. The overall amount or number of traded specimens or parts of specimens varied significantly across the transactions ranging from a few grams of a certain body part to a larger number of whole specimens. Moreover, types of traded goods and units differed significantly or were missing in the database. Therefore, this analysis did not take into account the relative sizes of each transaction, which may be the subject of future analysis.
14. Further research, ideally in collaboration with the CITES Secretariat, would be required to understand the full implications of international in CMS Appendix I-listed species. This may include a review of information contained in the CITES Illegal Trade Database in order to gather information about CMS Appendix I-listed species that were illegally traded with respect to CITES regulations. Moreover, a review of trade prior to 2015 may provide important insights into the development of trade over time and in particular if the inclusion of a species in CMS Appendix I had any measurable impact on the magnitude of trade in that species. Such additional information may also contribute to a closer review of threats in the context of the *Review of the Conservation Status of Migratory Species as contained in UNEP/CMS/ScC-SC4/Doc.8/Rev.1*.

Methods

15. Bearing in mind the challenges arising from the fact that CITES taxonomy differs from the CMS taxonomy and that CITES trade categories do not specifically address CMS regulations under Article III, the Secretariat applied a conservative approach for the present analysis. Only those transactions were included that were within the scope of Article III of the Convention with a high level of certainty. As a result, several transactions were excluded from the analysis.
16. CITES trade data for 2015-2018 were downloaded from the CITES Trade Database¹ using the 'Comparative Tabulation' option on the webpage. This option aims to match transactions with the same details that have been entered by both the exporting and importing country and to avoid duplicates in recorded transactions of the CITES database. However, duplications of a single trade transaction may occur when certain details are differently reported by the exporting and the importing Party (e.g. purpose or source code). Hence, in some cases, the numbers of transactions and levels of trade may be overestimated. Further research into the permit records of the relevant CITES Management Authority would be required to clearly identify those cases and to clarify the data.
17. For the purpose of the present analysis, CITES trade transactions meeting the following criteria were included in the analysis:

a) **CMS Appendix-I listed species** at species-specific level:

Transactions recorded at higher taxonomic level were excluded if not all species are included in the CMS Appendix I (e.g. data for *Cheloniidae spp.*, *Ursus arctos* and *Tursiops truncatus* were excluded). Only listed populations of species were taken into account. For example, the Mongolian population of the Saker Falcon and the Cheetah population of Namibia and Botswana, which are not listed in CMS App I, were excluded from the analysis).

b) **The ‘source’ of species or specimens traded:**

Only specimens taken from the wild are covered by Article III (5). Therefore, the transactions that were considered for this analysis included the following source codes:²

- R: Ranches specimens: specimens of animals reared in a controlled environment, taken as eggs or juveniles from the wild, where they would otherwise have had a very low probability of surviving to adulthood
- U: Source unknown
- W: Specimens taken from the wild
- X: Specimens taken in "the marine environment not under the jurisdiction of any State"

Other source codes as applied by CITES were not considered in the analysis as those were not indicating that the animals were taken from the wild (C, D, F – Bred or born in captivity) or at a time relevant time (O – pre-Convention). Also excluded were transactions in which the source code indicated that the traded good was confiscated.

c) **The ‘purpose’ of the recorded transaction:**

The analysis considers only transactions with purpose codes that are not included as exceptions in Art III (5) for taking of Appendix I listed species³. The purpose codes that were considered are the following:

- H: Hunting trophy
- P: Personal
- Q: Circus or travelling exhibition
- T: Commercial
- Z: Zoo

Transactions involving purpose codes that may be in accordance with exceptions under Article III (5) were excluded (M – Medical, B – Breeding in captivity, E – Educational, L – Law enforcement, N – Reintroduction or Introduction into the wild).

- d) As the exact date of the transaction is not recorded in the CITES trade database, only those transactions were considered where the species concerned was listed in CMS Appendix I at least during the year before the transaction.
- e) The results include only those transactions where at least one CMS Party was involved either as importer or exporter or both. A country was considered a Party from the first year after accession to the Convention onwards. Exporter and origin countries for which regional populations are not included in the CMS Appendix I were considered as Non-Parties for transactions involving those species (e.g.

Argentina and Bolivia for the Vicuna). Also, considered as Non-Parties were territories of Parties, for which the Party submitted a reservation (e.g. Greenland)

18. The number of recorded transactions that involved CMS Appendix I listed species between 2015 and 2018 which meet the criteria as described above are presented in **table 1**.
19. Further analysis was conducted to focus on specific transaction in which CMS Parties have imported from Non-Parties. Those results are presented in **table 2**.
20. Detailed information on the individual transactions that are included in the results are provided in **Annex 1** *Details of Trade Records by Taxonomic Group*.

Results

Table 1 shows recorded transactions in the CITES database that involve CMS Appendix I-listed species between 2015 and 2018. The table only presents transactions where at least one CMS Party was involved in the transaction as an importer and/or an exporter. Included in this table are also additional details concerning the transactions and the conservation status of the species. It should be noted that transactions involving specimens taken from the wild (i.e. with a source code 'wild') provide no indication as to whether the animal was recently taken.

Further details on each of the individual transactions recorded are provided in Annex 1 *Details of Trade Records by Taxonomic Group*.

Annex 1: Details of Trade Records by Taxonomic Group

The table below shows the details of each of the recorded transactions in the CITES database that involve CMS Appendix I-listed species for data entered between 2015 and 2018 and that were included in the analysis based on the criteria described in the methods. The transactions are grouped by taxonomic order with separate tables for *Aves*, *Elasmobranchii*, *Mammalia* and *Reptilia*. Indications have been made to distinguish if the importer, exporter and origin countries are Parties to CMS at the time of the transaction ('0' = No, '1' = Yes) and if they have submitted a reservation for a the listing of the species concerned ('0' = No, '1' = Yes).

For the purpose of ease of visualization, some countries have been abbreviated (e.g. 'USA' = United States of America, 'UAE' = United Arab Emirates, 'Korea/R' = Republic of Korea, 'Congo/DR' = Democratic Republic of the Congo) and the purpose code of 'Circus or travelling exhibition' has been shortened to 'Circus'.

As mentioned in the methods, duplications of a single trade may exist within the data when a certain detail differs (e.g. purpose or source code) between the input recorded by the exporter and importer of the same transaction.
