- 1. This document aims to provide details about the specific activities undertaken, coordinated and/or supported by the CMS Secretariat.
- 2. The document covers activities initiated after the Ninth Meeting of the CMS Conference of the Parties (Rome 1-5 December, 2008).
- 3. The attached table synthesizes information on individual activities focusing on progress in implementation and financial aspects when relevant. Additional information is provided in the column for comments when deemed appropriate.
- 4. Activities are grouped under the four objectives of the Strategic Plan, and how they link to individual Strategic Plan targets is identified.
- 5. While this report covers a large part of the activities included in the Work Plan of the CMS Secretariat for the triennium 2008-2011 it does not aim to provide a comprehensive picture of the range of activities undertaken by the Secretariat, but rather covers those activities of direct relevance to objectives and targets of the Strategic Plan.
