...the raptors conservation and research has a long history in the Czech Republic





- ✓ Advisory body for CMS NFP (CMS implementation)
- ✓ Advisory body for MoE in migratory species conservation

- ✓ Goal: to help the successful implementation of CMS and its instruments
- ✓ Usually 1 meeting a year (January, February)

## Challenges



- To facilitate the implementation of Raptors MoU and national raptors conservation through national raptor strategy
- To established a good and successful multisectorial cooperation (MoE, MoA, Mo Industry, Ministry of Interior and Police and hunting association)
- To find solution for Illegal killing (poisoning by carbofuran mainly!)
- ➤ Capacity building
- ➤ Public awareness
- To ensure the coordinated monitoring of all raptor species
- ➤ International cooperation

# Visions ...are in concordance with MoU priority actions



#### <u>General</u>

To ensure Raptors MoU implementation

#### Research

To asses and monitor the raptor populations and their status and threats

#### **Raptors protection**

To ensure the protection of all species from illegal killing, including poisoning, shooting and persecution

To contribute to the conservation of raptor habitats and important sites

#### **CEPA**

To strengthen training, education and communication processes to increase public awareness on the importance of raptors, their current plight and the threats that they face and the measures that need to be taken to conserve them.

The main operational goal of the WG for the period 2015-2017 has been the formulation of the National Raptors Conservation Strategy to implement the Raptors MoU and to improve the status of raptors in the Czech Republic
