### Introduction

- Uganda is located in the Eastern part of Africa and is a member of EAC
- The country has varied ecosystems and habitats and hence endowed with high diversity of wildlife species
- Due to enormous species diversity, rarity, endemicity and varied landscape, Sir Church Hill named it the Pearl of Africa.
- Uganda is home to more than half the world's remaining population of Mountain Gorilla

## Introduction cont.....

- Gorilla Conservation dates back 1950, 1970, 1989 (Banned) and formalized in 1991
- Uganda hosts 11% of the global bird diversity,
  7% of the global mammal diversity
- Visitor numbers to wildlife PAs are also on rise 138,000(2008) and 152,000(2009)reflecting an increase of about 10 percent
- Tourism revenues are significantly rising, now standing at over US\$400 million annually
- Gorilla Tourism-3Million USD per annum

## **Recent Conservation Approaches**

- Draft Revised Wildlife Policy is now ready for Stakeholder Consultations
- Establishment of Uganda Wildlife Research and Training Institute-Cabinet has already aproved
- Revenue Sharing (Statutory-USD 253,000 and Gorilla Levy-131,000 USD))
- Awareness-Friend a gorilla Programme
- Inclusion of Gorillas on the Ugandan currency and prioritization of tourism as a PEGD
- Ranger based monitoring programme and use of MIST for management decision making

# Approaches cont.....

- Community Conservation initiatives (Batwa Trail in MGNP)
- Health surveillance for Gorillas (Gorilla Clinic+Community Hospital) at Bwindi
- Enhanced Law enforcement (SWIFT)
- Regulated Gorilla Tourism (8 Gps available, 2 to be ready soon); BINP-33%-2006, Virunga-73%-2010
- Active participation in regional and international cooperation (CITES, LA, EAC, GVTC)
- A modern tourism information centre has been constructed at Mgahinga Gorilla National Park



- Human wildlife conflicts continue to negatively affect species and local communities alike
- Inadequate research to support conservation decision making
- Inadequate infrastructure to support service delivery and management of conservation areas
- Limited capital development budget for the conservation sector

# Way Forward

- Review and update conservation policies, plans and legislations to make them sufficiently enabling
- Demarcate and secure land titles for all wildlife Protected Areas
- Strengthening the Management, Research and Training institutions to deliver quality services
- Improve conservation infrastructure in Protected Areas
- Support interventions aimed at mitigating human wildlife conflicts
- Continue to seek for more funds to support sector programs
- Engage public private partnerships to foster conservation tourism infrastructure development
