#### **ADMISSION OF OBSERVERS**

- 1. Rule 4 Paragraph 3 of the Rules of Procedure for Signatory State Meetings of the Dugong MOU proclaims that '[a]ny agency or body technically qualified in the conservation and management of dugongs and their habitats, and which has informed the Secretariat of its desire to be represented at the meeting by Observers, shall be permitted to be represented unless at least one-third of the Signatories present object' and that '[o]nce admitted, these Observers shall have the right to participate in discussions but not to vote'.
- 2. Rule 4 Paragraph 4 states that '[b]odies and agencies desiring to be represented at the meeting by Observers shall submit the names of their representatives to the Secretariat prior to the opening of the meeting'.
- 3. The Annex to this document lists the agencies or bodies technically qualified to be represented at the meeting by observers who have pre-registered for the Third Meeting of Signatories by the date on which this document was prepared.
