## Action points arising from the Third Meeting of Signatory States to the IOSEA Marine Turtle MoU (Bangkok, 29- 31 March 2005)

The following action points are taken from the report of the Third Meeting of Signatory States (the relevant paragraphs in the report are indicated below). They have been sorted alphabetically according to the intended implementing country/MoU body. For ease of reference, they have also been organized and sorted in a second table, by theme.

These action points supplement the general and specific activities contained in the Conservation and Management Plan. Activities directed to non-Signatory States that are not yet participating formally in the IOSEA Marine Turtle MoU (country names shown in *italics*) are made in the spirit of constructive recommendations. (NB: In the text that follows, SS4 refers to the Fourth Meeting of the Signatory States.)
