Context and Aim

CMS Resolution 11.14 - *Programme of Work on Migratory Birds and Flyways* established the mandate to develop a Multi-species Action Plan to Conserve African-Eurasian Vultures (Vulture MsAP), under the auspices of the CMS Memorandum of Understanding on the Conservation of Migratory Birds of Prey in Africa and Eurasia (Raptors MOU). The mission is to bring together representatives of Range States, partners and interested parties, to develop a coordinated Action Plan for submission to CMS COP12, scheduled to be held in October 2017.

The main objectives of the Vulture MsAP Overarching Workshop are to:

- 1. Review the 1st consolidated draft of the Vulture MsAP, incorporating the four regional components from Africa, Asia, Europe and the Middle East, and other inputs;
- 2. Elaborate certain key strategic components of the Vulture MsAP which will not have been collectively considered at the four Regional Workshops; and
- 3. Engender and develop multi-lateral support, including identifying 'Vulture Champions'.
