## Addendum

## Background

1. By paragraph 9 of Resolution 11.1 on Financial and Administrative matters, the Conference of Parties decided that representatives from countries with contributions in arrears of three years or more should be excluded from holding office in Convention bodies and be denied the right to vote.
2. In addition, as per Rule 15 paragraph 2 of the Rules of Procedure adopted by the COP11 representatives of Parties that are three or more years behind in paying their assessed contributions on the date of the opening session of the $12^{\text {th }}$ meeting of the Conference of the Parties shall not be eligible to vote.
3. The same paragraph states that the Conference of the Parties may allow such Parties to exercise their right to vote if it is satisfied that the delay in payment arises from exceptional and unavoidable circumstances and shall receive advice in this regard from the Standing Committee. The exceptional and unavoidable circumstances shall be communicated in advance by the Party concerned to the Standing Committee for consideration at its meeting prior to the meeting of the Conference of the Parties.

## List of Parties with contributions in arrears of three or more years

4. In August 2017, the Secretariat sent individual letters to the Parties with unpaid contributions of three or more years as well as reminders about denied voting rights at the COP. The exact amounts of arrears and their breakdown were communicated by the Secretariat to each Party concerned. The Annex to this document provides further details concerning those Parties in arrears of three or more years as at 28 September 2017.
5. The Standing Committee at its $46^{\text {th }}$ meeting is expected to consider any possible submission by Parties concerned as regards exceptional and unavoidable circumstances outlined in the paragraph 3 above and transmit its advice to the Conference of the Parties.

## Recommended Action:

6. Parties are requested to keep these provisions in mind when considering nominations to the Standing Committee and the Sessional Committee of the Scientific Council.
