Progress Report of UNEP/CMS Office – Abu Dhabi

A. Background

- 1. UNEP/CMS Office in Abu Dhabi is funded by the Government of Abu Dhabi and hosted by the Environment Agency Abu Dhabi (EAD). The Office services as the Secretariat for the MoU on the Conservation of Migratory Birds of Prey in Africa and Eurasia, and the MoU on the Conservation and Management of Dugongs and their Habitats throughout their Range. This includes communication with range states and supporting partners, promotion of conservation projects/programmes, providing technical expertise, and supporting capacity building. The agreements also provide a platform for cooperation among governments and regions to develop and implement conservation measures to ensure the long term survival of the species.
- 2. The Dugong MoU, which took effect on 31 October 2007, counts currently 18 signatories, and the Birds of Prey MoU, which became effective on 1 November 2008, has 30 signatories (including one supporting International Organization). The UNEP/CMS Office Abu Dhabi has been actively supporting the implementation of the provisions of the MoUs, facilitating regional programmes especially for marine turtle conservation and coordinating with other conservation initiatives in the Gulf and Red Sea Region, to the greatest extent possible.
- 3. In addition, the Abu Dhabi Office delivers other CMS programmes in the Western Asia and Indian Ocean areas. Staff members at the Office represent the UNEP/CMS Secretariat in regional meetings of relevance when and where appropriate.
- 4. Towards achieving these main objectives the Office is taking initiatives to protect migratory species in line with the provisions of the above-mentioned MoUs through presentations and side events organisation. This was enhanced during various Dugong conservation workshops in Phuket (Thailand), Goa (India), Antananarivo (Madagascar) and Abu Dhabi (UAE). The last CBD CoP in Nagoya (Japan) has been a valuable occasion for CMS and its Abu Dhabi Office to raise public awareness on major migratory species' challenges.

B. Progress made since last report

- 5. The Host Country Agreement has been circulated to the UAE authorities for consultation and review before final signature by the Ministry of Foreign Affairs, EAD and UNEP. Currently the text is under consideration by Ministry of Foreign Affairs.
- 6. In the meantime, various challenging tasks for the Office have been launched and/or accomplished, including for example staff recruitment, IT issues, publishing an office brochure, and organising workshops and meetings. (For details kindly refer to the work plan in Annex 2.)
- 7. Regarding finances, the indicative budget 2009-2011for UNEP/CMS Office Abu Dhabi is presented in Table 1 in Annex 1. Apart from other budget lines, US\$ 365,000 represents the Small Grants Programme available for programme implementation of Dugong and BoP MoUs and regional turtle initiatives. Table 2 in Annex 1 is a statement of expenditure for 2010 not yet certified. However, the figures provided through IMIS system show that for almost dugong-related small grant programme expenditures the amount is US\$ 245,519.

i. Dugong conservation and management: MoU on the Conservation and Management of Dugongs and their Habitats throughout their Range

- 8. In accordance with its work plan the UNEP/CMS Office Abu Dhabi organised the First Official CMS Dugong MoU Signatory State Meeting in Abu Dhabi, 4-6 October 2010. An occasion where governments, International and Non-Governmental Organizations and experts from about 30 countries discussed solutions to protect the world's only herbivorous mammal living in marine waters. The meeting concluded that the conservation strategy should address the need for greater protection of marine biodiversity by combining different conservation tools. At the meeting, Bahrain, Palau, Seychelles, Vanuatu and Yemen signed the CMS Dugong agreement bringing the number of signatories to 18. More countries are likely to follow in the near future. The next Dugong MoU meeting will take place on 2012.
- 9. A Dugong Catch/Incidental Catch Survey Tool, developed by a group of technical advisors, has produced some quality data from 20 countries in the Pacific Islands, South Asia and the United Arab Emirates. The data will be combined into a geographical information system to identify the trouble spots, provide crucial information on existing populations and map important habitat areas. In 2011, the survey will be extended to Range States in East Africa and the Western Indian Ocean littorals, North West Indian Ocean as well as South Asian regions.
- 10. Other solutions to protect valuable dugong habitat include establishing spatial closures as marine reserves and temporal constraints to fishing operations. Incentives, such as loans for buying dugong-friendly fishing gear, educational campaigns and measures to improve the livelihood of local communities were also considered as a way to complement conservation efforts. Potential pilot projects will be developed to implement these new incentive based tools from which other marine species may benefit as well.
- 11. The UNEP/CMS Abu Dhabi Office will continue to work with the EAD and other partners to identify opportunities for regional collaboration to implement the Conservation and Management Plan for Dugong in Western Indian Ocean Sub-Region.
- 12. For example, during the 2nd Marine Conservation Forum, Abu Dhabi, UAE, the Office will participate through a side event agreed with the organizer (Emirates Wildlife Society in association with the World Wildlife Fund, EWS-WWF) and group discussions with participants from GCC area, aiming at exploring opportunities for regional cooperation in the implementation of dugong and marine turtle conservation initiatives.

ii. Conservation of migratory birds of prey: MoU on the Conservation of Migratory Birds of Prey in Africa and Eurasia

- 13. The contract of Programme Officer Birds came to end in August 2010, and a new Programme Officer is under recruitment. Until the position is filled, the Executive Coordinator takes on any urgent/pending tasks of the MoU Interim Coordinating Unit (ICU).
- 14. A Small Scale Funding Agreement (SSFA) was established in September 2010 with the Ministry of Environment and Forests of Madagascar, for launching a National Strategy elaboration, more specifically to establish Action Plans for Falco eleonorae and Falco concolor protection.
- 15. More SSFAs are encouraged for the coming year, such as, but not restraint to the elaboration of a regional plan research strategy on Falco concolor monitoring, as well as a UAE national strategy with EAD and a partner.
- 16. In November 2010 the Signatories to the MoU were requested for comments on a document established by the ICU: Guidelines for Preparing National or Regional Strategies in the Framework of the MoU on the Conservation of Migratory Birds of Prey in Africa and Eurasia. The guidelines are aiming at assisting in the preparation for the first Meeting of the Signatories to the Birds of Prey MoU.
- 17. A workshop on the conservation of migratory birds of prey is being scheduled for 2011, depending on the recruitment of the Programme Officer, and the First Meeting of the Signatories to the Birds of Prey MoU envisaged for year 2012. The earlier most of signatories will provide their strategies to the ICU the better determined the meeting date will be.
