MEETING REPORT

(Prepared by the Coordinating Unit of the Raptors MOU)

1. Welcome, Introductions and Meeting Agenda

The Coordinating Unit opened the meeting by welcoming all participants and giving the floor to Mr Des Thompson, elected Chair of the TAG until the Third Meeting of Signatories to the Raptors MOU (MOS3), who invited all meeting participants (refer to Annex 1) to introduce themselves.

Meeting participants agreed to an agenda for the meeting.

2. Election of TAG Chair and Vice-Chair

The election of the TAG Chair and Vice-Chair was led by Mr Thompson. The meeting consensually elected Mr André Botha as new Chair of the TAG and Mr Mátyás Prommer as new Vice-Chair of the TAG. Mr Botha, as newly elected Chair, chaired the meeting from this point onwards.

3. Presentations by TAG Members on Ongoing Research Relevant to the TAG Workplan 2023-2026

Ms Darcy Ogada shared with the Group some updates relating to regional action plans in East Africa and red listing of species in the region. She informed the Group that Tanzania completed its National Conservation and Management Plan for Vultures in December 2023, and that Kenya anticipated completion of its Vulture Multi-Species Action Plan in March 2024.

Mr Neil Deacon indicated that Zimbabwe was undertaking work to address belief-based use of vultures.

Ms Fadzai Matsvimbo informed the Group that conversations were ongoing with the Southern African Development Community (SADC) to adopt the CMS Multi-Species Action Plan to Conserve African-Eurasian Vultures (Vulture MsAP) and address the issue of lead poisoning through the delivery of an action plan.

Mr Ohad Hatzofe shared some research findings on dispersal patterns of Bonelli's Eagle, a species found to be greatly affected by electrocution. He also shared some details on the progress that Israel had been making to address that cause of mortality.

Mr Mohammed Shobrak indicated that the Kingdom of Saudi Arabia had been discussing the issue of Diclofenac use with the World Organisation for Animal Health. He also noted that a vulture project had been initiated in the northern part of the country.

The Group agreed to Ms Vicky Jones, Mr Hatzofe and Mr Shobrak co-drafting a concept document on how to address the issue of the CMS definition of migratory species applying to juvenile and sub-adult individuals' movements. The three TAG members agreed to develop the draft document and share it with the Group ahead of its next meeting.

The TAG Chair informed the Group that the Raptors MOU had engaged the Endangered Wildlife Trust to conduct a mid-term review of the CMS Vulture MsAP. As part of the review, a questionnaire had been prepared and sent out across the MsAP's range. A total of 103 responses had been received from countries and various organisations working on vulture conservation. A resulting initial draft report on findings was submitted to the Coordinating Unit in November 2023, and the final version of the report was anticipated to become available by the end of January 2024.

4. Overview of the TOR of the TAG

The Coordinating Unit reminded the Group of its mandate, as well as of how to find relevant pages with information on the TAG on the Raptors MOU website.

5. Review and Update of the of the TAG Workplan 2023-2026

The Coordinating Unit briefed the Group on the review and update process of the TAG Workplan 2023-2026 following MOS3.
