



## Memorandum of Understanding on the Conservation of Migratory Birds of Prey in Africa and Eurasia

### ESTABLISHMENT OF THE TECHNICAL ADVISORY GROUP

*Prepared by the Coordinating Unit of the Raptors MoU*

#### Introduction

1. An Interim Technical Advisory Group (TAG) was established at the First Meeting of Signatories (MoS1) to the Raptors MoU as a technical advisory body to provide expert advice, information and to make recommendations on the implementation of the MoU to Signatories and the Coordinating Unit.
2. According to the Terms of Reference (ToR) for the TAG (UNEP/CMS/Raptors/MOS2/Inf.2), adopted at MoS1, all members of the Interim TAG would serve until the Second Meeting of Signatories (MoS2). In March 2015, the Coordinating Unit circulated a call for nominations amongst Signatories and Co-operating Partners for raptor specialists to serve on the TAG to be established at MoS2. In total, 17 nominations were received by the deadline of 8 April 2015 – the timescale designated in the ToR of 180 days before the forthcoming MoS.
3. Paragraph 10 c) of the ToR describes the procedure to establish the TAG at MoS2 and future meetings of Signatories, including that: *'[...] The regional representatives and other experts will be appointed by the MoS at the recommendation of a Panel which shall comprise the current Chair and Vice-chair of the TAG, and the CU's Programme Officer and Executive Coordinator. The Panel will be chaired by the TAG Chair'*. Accordingly, a selection Panel was established comprising Prof. Des Thompson, Dr. Sàlim Javed, Mr. Nick P. Williams and Mr. Lyle Glowka.
4. The selection Panel convened via two meetings held on 17 and 26 August 2015. This document contains the report and recommendations that emerged from the Panel's deliberations. The assessment process followed that set out in the ToR, which also outlines the purpose and main tasks, size and composition, nomination and appointment of members, officers, and the *modus operandi* of the TAG.

#### Size and composition

5. Paragraph 5 of the TAG Terms of Reference states that: *'Membership of the TAG shall comprise persons operating in their personal capacity, and qualified as specialists in raptor research, conservation and/or management. In appointing persons to the TAG, the MoS should strive to achieve a balance amongst areas of expertise especially in the context of delivery of advice requested of it, and the need for representation of those geographic regions with few Signatories'*.
6. And paragraph 6 of the TAG Terms of Reference provides the following guidance concerning the size and composition of TAG:

- a) '10 members nominated by Signatories from the four main geo-political regions covered by the Raptors MoU, namely: Africa (excluding North Africa) – three representatives; Asia – two representatives; Europe – three representatives; and, the Middle East and North Africa – two representatives;
- b) Up to five other experts;
- c) One person nominated by BirdLife International – the IUCN nominated authority on birds; and,
- d) To promote synergies and co-operation, observers from the African-Eurasian Waterbirds Technical Committee, the CMS Landbirds Action Plan and Co-operating Partners may attend at their own cost'.

### Approach and assessment criteria

7. As part of the UN commitment to fairness, equal opportunity and diversity, all candidates were treated in exactly the same way throughout all aspects of the assessment process. Each of the nominations was assessed and scored based on the six criteria described below. In addition, in line with Rule 14(3) of the Rules of Procedure adopted by Signatories at MoS1 of the Raptors MoU (UNEP/CMS/Raptors/MOS2/3), the Panel satisfied itself that all the nominations could communicate effectively in English, which is the working language of TAG. At the outset the selection Panel also agreed to assume that all candidates met two basic criteria established in the ToR, as follows:

- *Full access to electronic mail and web-based information and communication systems, through which the inter-sessional work of the TAG will take place; and,*
- *Commitment to undertake the work required of the TAG with the support, where relevant, of the member's organization or institution.*
- **Networking:** Demonstrated capacity for networking with other experts in raptor research, conservation and/or management of species and their habitats at a local, national and international scale, and demonstrated engagement in such expert networks. **Scoring was from 1** (no data provided or irrelevant to raptor conservation) to 5 (member of any association related with raptor conservation at international scale and demonstrated engagement in such expert networks).
- **Recognized expertise:** Widely recognized experience and expertise in one or more aspects of raptor research, conservation and/or management of species and their habitats, particularly to the work of the TAG. **Scoring was from 1** (no data provided or irrelevant for raptor conservation) to 5 (at international scale and in relevant subjects for raptor research, conservation and/or management of species and their habitats).
- **Work experience:** Experience working with raptors, conservation and/or management of species and their habitats, particularly those relevant to the work of the TAG. **Scoring was from 1** (no data provided or irrelevant to raptor conservation) to 5 (experience at the international scale relevant to raptor conservation and/or management of species and their habitats).
- **Education:** University level or higher education related to raptor conservation and/or management of species and their habitat. **Scoring was from 1** (no data provided or irrelevant to raptor conservation) to 5 (university level or higher education related to raptor conservation and/or management of their habitats).
- **Multi-level working:** Professional experience at different levels (local (regional), national and international) and displaying different low, medium and /or high level roles related to raptor

conservation or habitat management. **Scoring was from 1** (at local (regional) level) to 5 (at international level, including decision making roles).

- **Publications on raptors:** Relevance to raptor conservation and/or management of species and their habitats, particularly species listed on Raptors MoU, papers published in recognized (peer reviewed) journals and magazines, including as principal author. **Scoring was from 1** (no data provided or irrelevant to raptor conservation) to 5 (many publications on relevant subjects for raptor conservation and/or management of species and their habitats, in respected media and as principal author).

8. The Panel carried out the assessment using a two-step process: firstly ensuring the suitability of the applicant to be a member of the TAG (candidates were scored based on the above six criteria); and, secondly, trying to fill the expertise gaps.

### Proposals for membership of TAG

9. Of the total of 17 nominations, nine were nominated by Signatories, seven by two Co-operating Partners (BirdLife International and the International Association of Falconry and Conservation of Birds of Prey (IAF)), and one representative nominated by BirdLife for their reserved position on the TAG. As a result of the assessment process, one candidate (with the lowest scoring) was considered not eligible for TAG membership at the current time, due primarily to his lack of experience, lower recognized expertise and limited multi-level working in comparison with the other nominations.

10. All nine nominations received from Signatories were considered suitable to serve on TAG by the Selection Panel. Allocating these candidates into their respective regions left two spaces for Regional Representatives (Africa and Asia) and also meant that there was an extra member proposed for the European Region. The Selection Panel concluded that the two vacant spaces could be appropriately filled by two of the candidates nominated by Cooperating Partners, and that due to the extensive knowledge, experience and expertise of one of the nominations from Europe, he could better serve on TAG in an Expert role. The remaining four successful candidates nominated by Cooperating Partners neatly completed the required compliment of five Experts. The Selection Panel was fully satisfied with skills, qualifications and expertise of the candidate proposed by BirdLife International to serve as their representative on TAG.

11. Accordingly, the Selection Panel proposes the following composition of TAG to serve from MoS2 onwards:

- a) Ten members covering four main geo-political regions covered by the Raptors MoU:
  - Three Representatives from Africa (excluding North Africa):

    2. Lily-Arison Rene de Roland (Madagascar)
    3. Neil Crossland Deacon (Zimbabwe)
  - Two Representatives from Asia:
    4. Umeed Khalid (Pakistan)
    5. Nyambayar Batbayar (Mongolia)
  - Three Representatives from Europe:
    6. Des Thompson (United Kingdom)
    7. Mátyás Prommer (Hungary)
    8. Jari Valkama (Finland)
  - Two Representatives from Middle East and North Africa:
    9. Sàlim Javed (United Arab Emirates)
    10. Sadegh Sadeghi Zadegan (Iran)

## b) Five Experts:

1. Jean-Marc Thiollay (France)
2. Mohammed Shobrak (Saudi Arabia)
3. Munir Z. Virani (Kenya)
4. Vibhu Prakash (India)
5. Fernando Feás Costilla (Spain)

## c) One Representative nominated by BirdLife International (BLI):

Vicky Jones (Based at BLI headquarters in the United Kingdom)

12. In summary, in line with the ToR, the selection Panel proposes a TAG membership of 16 individuals (Table 1), comprising 10 Regional Representatives, five Experts and one Representative from BirdLife International ('Red List' authority on birds delegate by IUCN). Summary Personal Profiles of the persons recommended for membership of the TAG are presented in the Annex to this document. Thirteen of the members served effectively on the Interim TAG since MoS1, which ensures a high level of continuity and promotes collaborative working within the group.

#### 1. Nyambayar Batbayar

Major government level decision support (for Ministry of Environment of Mongolia and Korean Cultural Heritage Administration). Director and Research biologist for the Wildlife Science and Conservation Center, since 2005 and Research Assistant, Center for Spatial Analysis at University of Oklahoma, since 2009. M.Sc. in Raptor Biology and PhD student at University of Oklahoma. Large number of publications in recognized magazines as 1<sup>st</sup> or 2<sup>nd</sup> author in raptors and in relevant threats. Expertise in vultures and threats.

#### 2. André Botha
