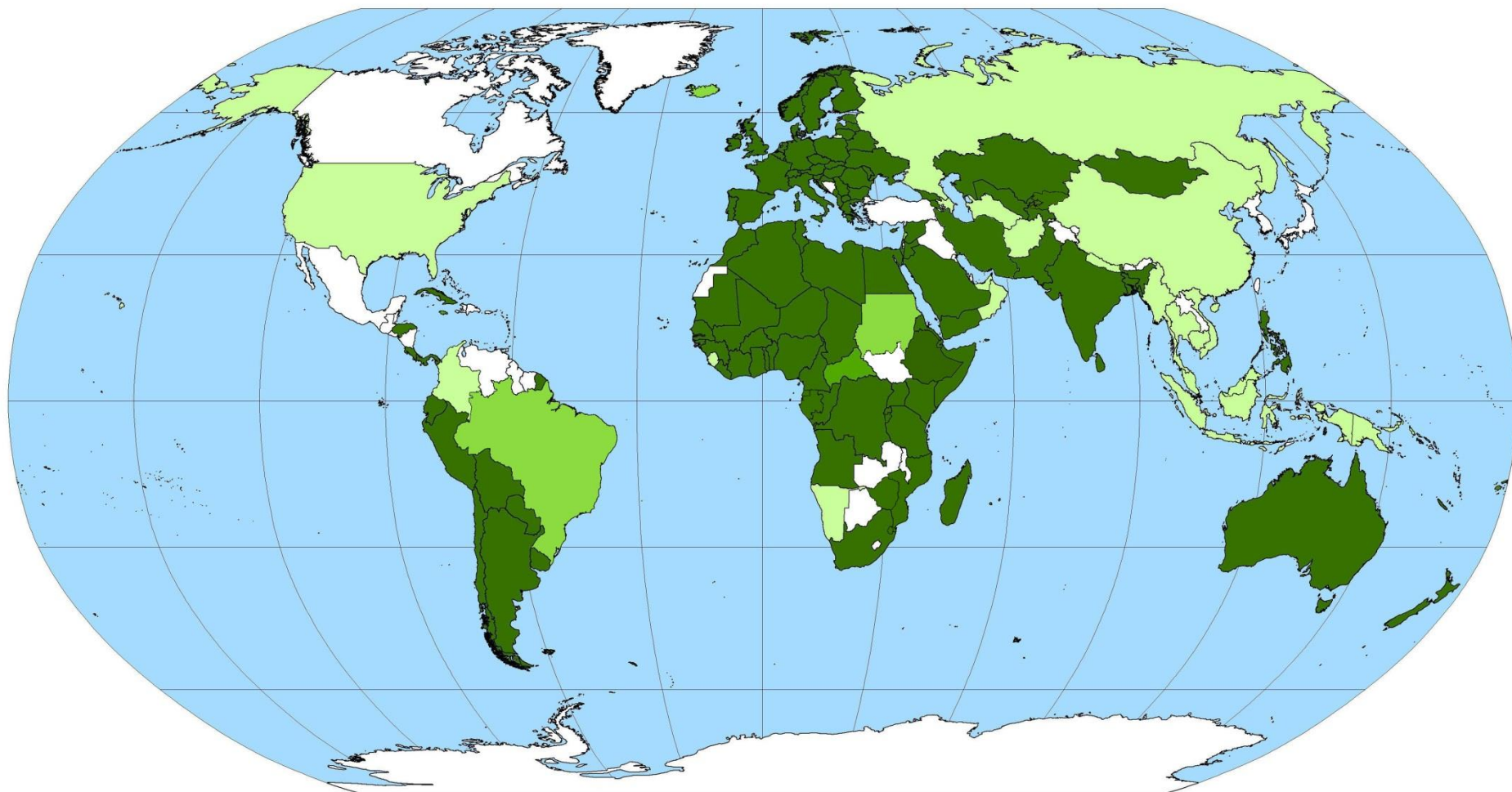






Convention on the Conservation of Migratory Species of Wild Animals

Map of 120 Parties (as of 1 May 2014)

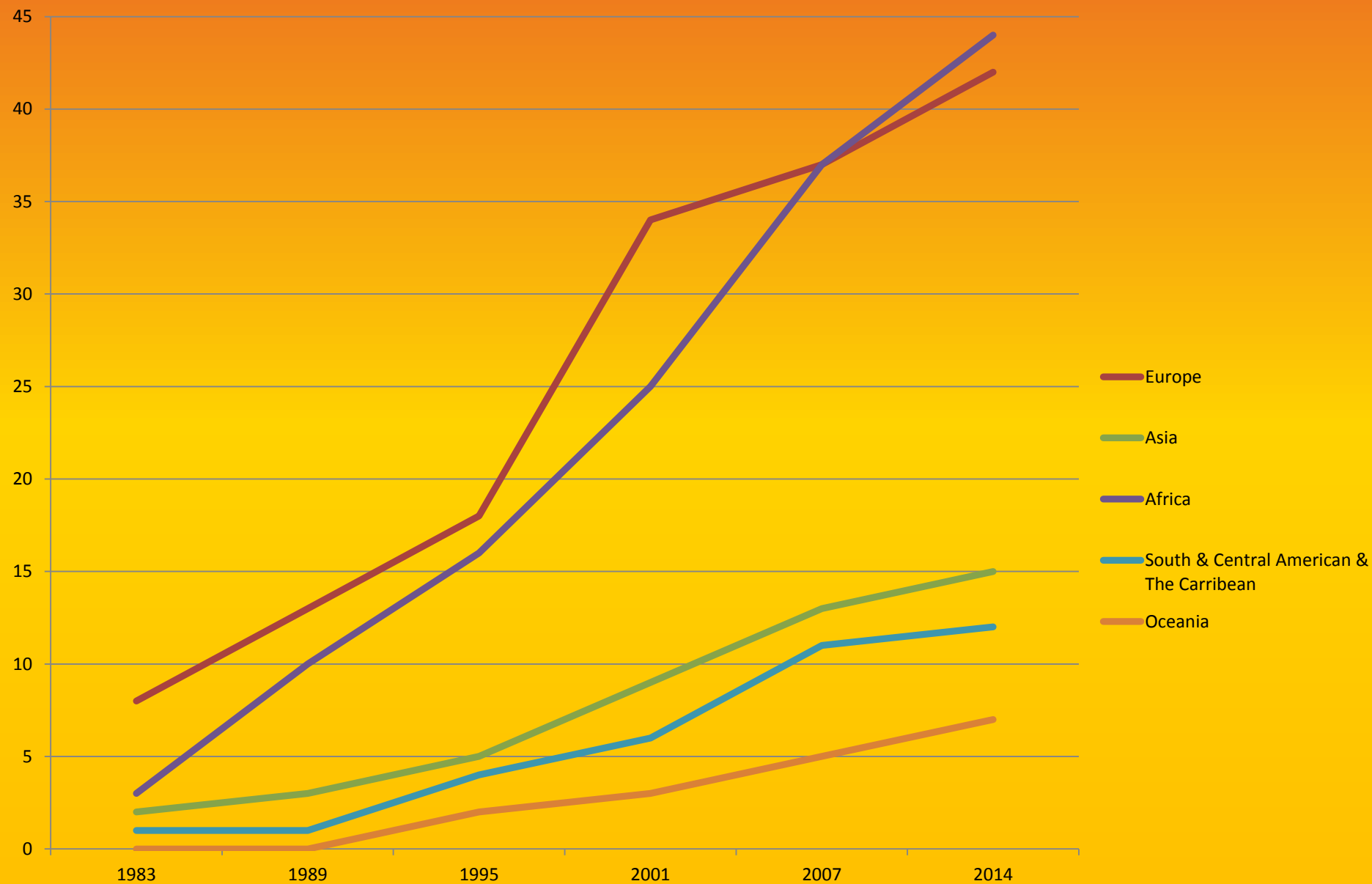

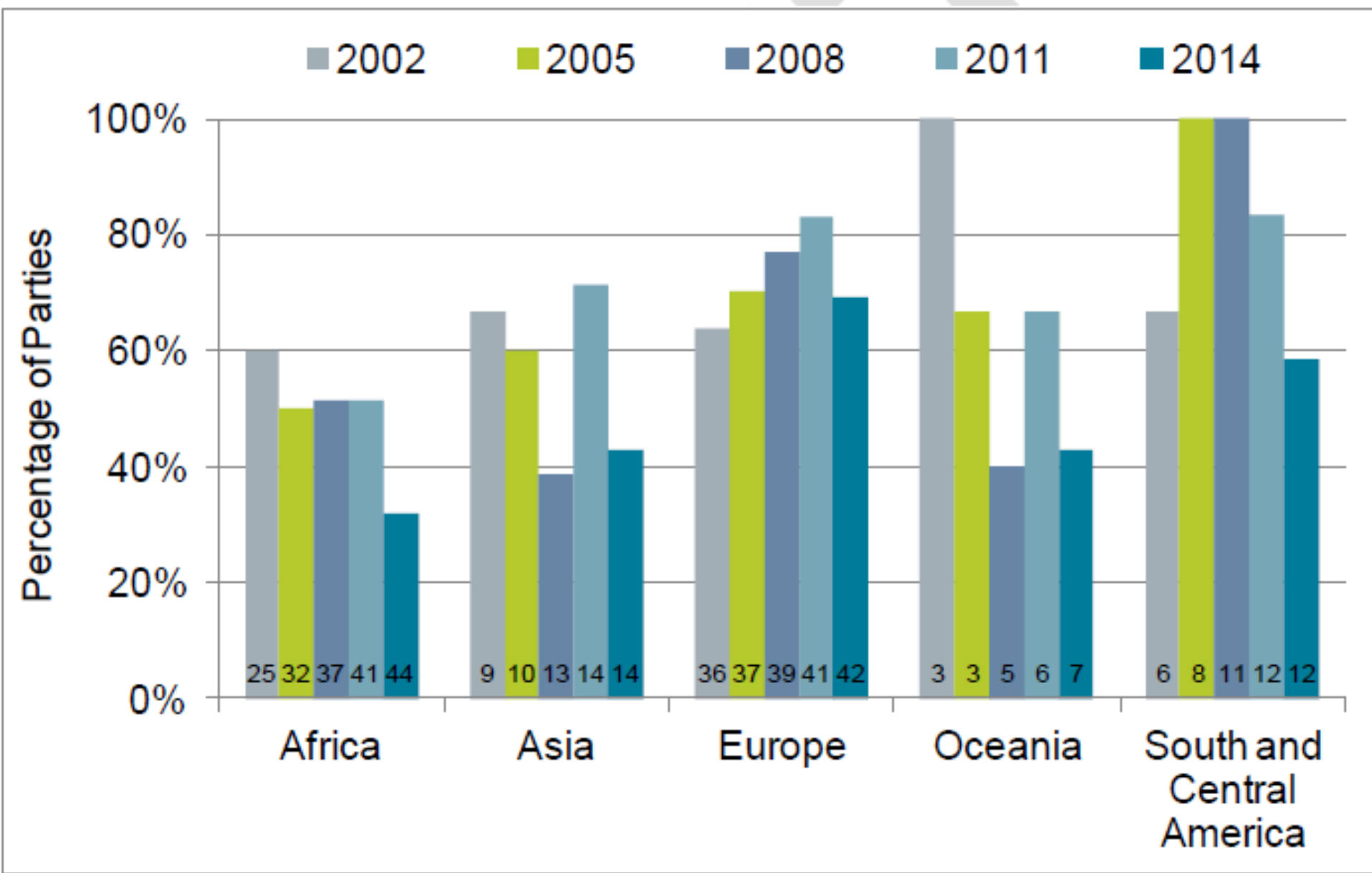

- 24 Countries at Pre-COP Workshop in Zimbabwe

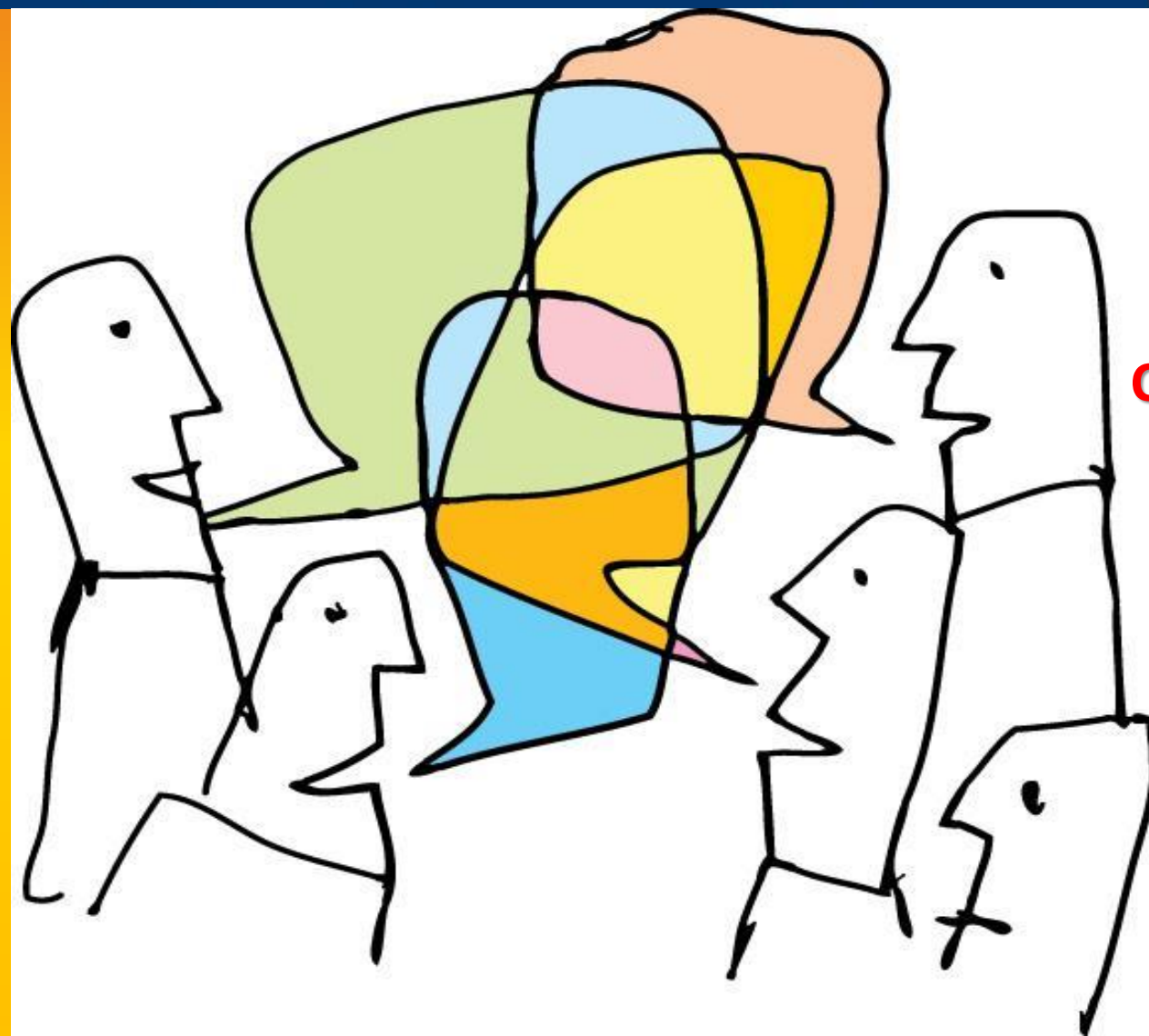
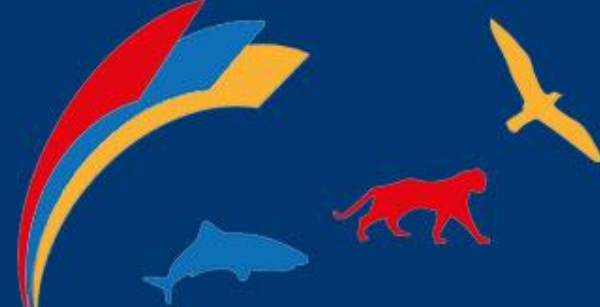
