## **Report from Spain**

- III. Title of initiative/project(s) being reported: No specific initiative/project has been proposed within the framework of the AEMLAP. Nonetheless, there are other activities aimed at protecting individuals and important areas for migratory landbirds included in monitoring programs other than AEMLAP in Spain:
  - a. Wintering and breeding atlas of Spanish bird species covered by AEMLAP
    - i. Time frame: 1999-2017.
    - ii. Addressed issue: research on distribution and relative abundance of bird populations.
    - iii. Actions and achievements: three breeding and one wintering atlas. Partially funded by national and regional administration and volunteer work.
  - b. Special Protected Areas (SPA) for birds within the framework of the Birds Directive (147/2009/CE).
    - i. Time frame: 1986-ongoing.
    - ii. Addressed issue: These areas are established to enhance the protection of birds included in Annex I of Birds Directive, and their habitats.
    - iii. Actions and achievements: 608 identified, declared and managed areas covering >20% of terrestrial Spain.

For reasons of economy, this document is printed in a limited number, and will not be distributed at the meeting. Delegates are kindly requested to bring their copy to the meeting and not to request additional copies.

- c. Monitoring of protected species to fulfil requirements from Article 12 of Birds Directive.
  - i. Time frame: 1992-ongoing.
  - ii. Addressed issue: periodic reports of the conservation status of protected birds each 6 years.
  - iii. Actions and achievements: data obtained from bird monitoring schemes form regional authorities and NGOs. Partially funded by national and regional administration and volunteer work.
- d. Action plans for endangered terrestrial bird species covered by AEMLAP.
  - i. Time frame: 2007-ongoing.
  - ii. Addressed issue: establishing conservation and management activities legally binding.
  - iii. Actions and achievements: 14 regional action plans for seven species (*Riparia riparia, Emberiza schoeniclus lusitanica, Tetrax tetrax, Otis tarda, Pterocles alchata, Pterocles orientalis, Chersophilus duponti*). Funded by regional administrations.
- e. Spanish ringing schemes (ICONA and Aranzadi).
  - i. Time frame: 1956-ongoing.
  - ii. Addressed issue: research on migratory patterns and different ecological and demographic parameters.
  - iii. Actions and achievements: 1 100 bird ringers working for joint coordinated programs (at least 5 at national scale) studying  $\pm$  350 000 birds/year. Partially funded by national administration and volunteer work.
- f. Implementation and prosecution of illegal activities related to trapping and killing terrestrial birds.
  - i. Time frame: 2010-ongoing.
  - ii. Addressed issue: enforcement of European and national legislation on bird protection.
  - iii. Actions and achievements: banning of non sustainable/legal hunting (*parany*) and regulation/adaptation of finches trapping (*silvestrismo*).
- g. Reconciling measures from damages of terrestrial birds.
  - i. Time frame: 2007-ongoing.
  - ii. Addressed issues: Reducing wildlife conflicts to allow coexistence as established in European and national regulations.
  - iii. Actions and achievements: damage mitigation/compensation to crops (*Otis tarda, Tetrax tetrax*) and to beekeeping (*Merops apiaster*). Funded through agro-environmental funding (FEADER, Regulation 1305/2013 CE), and national insurances programs (ENESA).
