

**FOURTH MEETING OF SIGNATORY STATES TO THE MEMORANDUM OF
UNDERSTANDING ON THE CONSERVATION AND MANAGEMENT OF DUGONGS
(*DUGONG DUGON*) AND THEIR HABITATS THROUGHOUT THEIR RANGE**

Summary: This document reports on the implementation of the Programme of Work 2017-2019 and introduces a Programme of Work to guide the work of the Secretariat during 2024-2027.

The Meeting is invited to: (a) take note of the report on implementation of the Programme of Work 2017-2019; (b) endorse the Programme of Work 2024-2027; and (c) ensure that the outcomes of MOS4 are duly reflected in the newly adopted Programme of Work.

1. At the Third Meeting of Signatory States to the Dugong MOU (MOS3, Abu Dhabi, March 2017), the Secretariat of the Dugong MOU presented a Programme of Work 2017-2019 outlining priorities for supporting the implementation of the MOU between 2017 and 2019. That Programme of Work was presented in document CMS/Dugong/MOS3/12.1.
2. At MOS3, the Secretariat explained that the priorities identified in the Programme of Work 2017-2019 were to develop incentive-based projects and seek additional funding from institutions such as the Global Environment Facility (GEF) and the International Climate Initiative (IKI), along with funds dedicated to advancing the United Nations Sustainable Development Goals (SDGs). Priority initiatives included: the South East Andaman Community Tourism and Seagrass Initiative, focusing on exploring community tourism opportunities, incentives and community-based enterprise models: the Aquacelerator Initiative, led and funded by the Australian Government Department of Foreign Affairs in partnership with SecondMuse; and the Gulf Collaboration Concept and Red Sea Collaboration initiatives (refer to document CMS/Dugong/MOS3/Report*, paragraphs 114-126).
3. At MOS3, the Secretariat emphasized several crucial actions to advance dugong and seagrass conservation efforts. These included promoting the utilization of tools such as the CMS Dugong Catch & Bycatch Questionnaire and the Dugong and Seagrass Research Toolkit. Additionally, there was a call to foster collaboration with the private sector, continue capacity-building initiatives; and facilitate knowledge-sharing through the Dugong MOU website. Furthermore, efforts to support Signatory States and Range States, work with the Dugong Technical Group (DTG), integrate dugong and seagrass conservation into mainstream policies, and engage with the broader CMS Family on cross-cutting issues such as bycatch, marine noise and vessel strikes were highlighted as essential strategies moving forward.
4. The Programme of Work 2017-2019 was endorsed at MOS3 (refer to document CMS/DUGONG/MOS3/Report*, paragraph 126). To track its implementation, the Secretariat has compiled activities into a structured table provided in Annex 1 of this document. The table delineates the status of each activity and directs Signatory States to additional information on implementation progress.
5. The Secretariat extends its gratitude to the Environment Agency – Abu Dhabi for the generous financial support provided to the CMS Office – Abu Dhabi on behalf of the Government of the United Arab Emirates, enabling the Secretariat to execute activities outlined in the Programme of Work 2017-2019 since MOS3. Additionally, the Secretariat acknowledges the voluntary contribution received from Australia in 2023, further supporting the ongoing efforts to advance dugong and seagrass conservation initiatives. The financial status of the Secretariat is reported in document UNEP/CMS/DUGONG/MOS4/Doc.15.1.
6. The Secretariat has prepared a proposal for a new programme of work to guide its activities for the period 2024-2027. This proposed Programme of Work 2024-2027, found in Annex 2 of the current document, lists activities directed to the Secretariat from various sources, including:
 - (a) MOU Text.
 - (b) Conservation and Management Plan for the Dugong MOU, as proposed for amendment in document UNEP/CMS/DUGONG/MOS4/Doc.13.1(Rev.1).
 - (c) Rules of Procedure for Meetings of Signatory States to the Dugong MOU adopted at MOS3, as proposed for amendment in document UNEP/CMS/DUGONG/MOS4/Doc.2.

- (d) Terms of Reference of the Dugong Technical Group, as presented in document UNEP/CMS/DUGONG/MOS4/Doc.10.
