# **Doc 02: Process Information**

(Prepared by the Aquatic Wild Meat Working Group)

- 1. The virtual and face-to-face process to develop a CMS West African Aquatic Wild Meat Action plan will be held between late June and September 2023, ahead of CMS COP14 (Samarkand, Uzbekistan October 23-28, 2023). This process is hosted by the Government of Benin and Chaired by Professor Alfred Oteng-Yeboah (Ghana).
- 2. This process offers the opportunity to convene the CMS Party Range States of West Africa to give focused attention to a growing threat to CMS-listed aquatic species in the region.
- 3. Attendees, including experts and stakeholder observers, will work through a process of four virtual meetings addressing four themes:

#### Fostering community-driven solutions, and building laws and enforcement

Each theme will provide focused attention on necessary capacity building (local and regional), demonstrating clear pathways for funders to provide capacity support. A draft action plan (Doc 03) will evolve as the meetings progress.

4. The virtual meetings and the action plan draft will then culminate in a face-to-face meeting in September.

- 5. The virtual meeting will take place through Zoom, with simultaneous translation between French and English provided throughout each session. Each session will be 3 hours long, with a 15-minute break at 1.5 hours.
