Deterrent against crime

- Vehicular patrols
- Covert observation
- Stationary observation posts
- Foot patrols
- Physical inspections
- Spot-checks on individual hunters
- Roadblocks



NGO Involvement

- Act as deterrent;
- Provide day to day information about the presence of birds;
- Monitoring of roosting sites;
- Ocular witnesses of illegal incidents;
- Gathering of video/photographic evidence;
- Providing evidence during court cases.
