PROPOSALS FOR THE AMENDMENT OF ANNEX 1 TO THE MEMORANDUM OF UNDERSTANDING ON THE CONSERVATION OF MIGRATORY SHARKS

(Prepared by the Secretariat)

- 1. In accordance with paragraph 20 of the MOU, any amendments to Annex 1 should be assessed by the Signatories at each session of the Meeting of the Signatories.
- 2. As agreed at the First Meeting of the Signatories to the Sharks MOU (MOS1), any shark and ray species listed on the CMS Appendices will automatically be considered by the Advisory Committee as a proposed listing for Annex 1 of the MOU (CMS/Sharks/Outcome 1.4 Modifying the species list).
- 3. At the 10th Conference of the Parties to the Convention (COP10), the giant manta ray (*Manta birostris*) was included in Appendices I and II of the Convention.
- 4. At COP11, the reef manta ray (*Manta alfredi*), all nine species of mobula rays (*Mobula* spp) and all five species of sawfishes (Pristidae spp) were added to CMS Appendices I and II, while the great hammerhead shark (*Sphyrna mokarran*), the scalloped hammerhead shark (*Sphyrna lewini*), all three species of thresher sharks (*Alopias spp*) and the silky shark (*Carcharhinus falcilformis*) were added to CMS Appendix II.
- 5. Following the agreed procedure, the Secretariat transmitted all original proposals for the inclusion of shark and ray species in CMS Appendices in the form in which they were submitted to COP10 and COP11 to the Advisory Committee for review. The Committee's assessments are presented as documents CMS/Sharks/MOS2/Doc.8.2.10-8.2.18.
- 6. As further agreed, all proposals were submitted in their original form to this Meeting for consideration by the Signatories within the 150 day deadline before the meeting as documents CMS/Sharks/MOS2/Doc.8.2.2-8.2.9. The Signatories were subsequently invited to provide any comments on the text to the Secretariat at least 60 days before the meeting. Within this consultation period no comments have been received.
