Meeting venue



From the airport you can take RER B train, followed by a short Metro line (5, 10). Journey will take about an hour.



Hotel accommodation

September in Paris is generally on the moderately warm and damp side, with average temperatures at around 24 degrees C/75 F, could be rainy, minimum 13 C/55F.

Electricity

Electricity in France conforms to the European standard of 220V to 230V, with a frequency of 50Hz. Wall outlets typically accommodate plugs with two or three round pins (the latter earthed, the former not).

Currency

France's currency is the Euro. As of 1st March 2019, the exchange rate is €0.88 for 1US\$.

Credit cards are accepted in hotels and most restaurants in Paris. For small purchases cash is preferred. Foreign exchange services in banks and exchange offices are widely available in the city center.
