## EAC Strategy to Combat Poaching and Illegal Trade and Trafficking of Wildlife and Wildlife Products- Updates and New Directions - EAC (14:30-15:30)

The EAC is home to abundant and diverse species of fauna and flora. It is inhabited by some of the biggest populations of charismatic mega fauna including elephant, rhinoceros, lion, chimpanzee, mountain gorilla and various species of antelopes, birds, butterflies, reptiles, fish and a variety of flora. The region is characterized by transboundary ecosystems and cross-border protected areas. However, this endowment was threatened by high levels of illegal wildlife trade and poaching. The region responded by developing a Regional Strategy to Combat Poaching and Illegal Trade and Trafficking of Wildlife and Wildlife Products that has been under implementation at the regional and national levels. The Strategy revolves around six key pillars including strengthening of policy framework, enhancing law enforcement capacity, research and development, involvement of local communities and strengthening the regional and international collaboration. The Session will entail sharing the key highlights of the Strategy and the status of implementation at both the regional and national levels through a presentation and panel discussions involving Partner States.

## Addressing the impacts of Linear infrastructure on migration and transboundary conservation (15:30-16:30)

Infrastructure development fragments and destroys habitat and creates barriers to the movements of species, thereby isolating populations and preventing access to essential resources such as food and water, causing die-offs and reduced fitness. Infrastructure also causes direct injuries and mortality through collisions as well as disturbance and pollution. The loss of ecological connectivity leads to genetic isolation, leaving smaller populations more vulnerable and prone to local extinction. Infrastructure development may cause other indirect impacts such as increased killing of wildlife due to easier access. This presentation will share findings from the CMS' work on infrastructure and recommendations for how countries and collaborate to reduce its impact.

## Restoring an Elephant Corridor to Enhance Human-Wildlife Coexistence in Southern Tanzania (17:30-18:30)

Wildlife corridors are becoming increasingly recognized as a key component of enhancing human-wildlife coexistence around the world, necessitated by rapid anthropogenic land use change and shrinking natural habitat. However, we are in the early stages of understanding how to restore and effectively manage corridors in dynamic landscapes.

Since 2014, Southern Tanzania Elephant Program (STEP) has worked with farmers on beehive fence projects to mitigate the effects of elephants as they continue to cross the Kilombero Valley through an anthropogenic, high-risk landscape. In October 2018, STEP began facilitation of a Government-led project to restore the Selous-Udzungwa Wildlife Corridor to provide a long-term solution to this Human-Wildlife Conflict. This is a pioneering and unprecedented initiative in Tanzania, coinciding with publication of the first Regulations on Wildlife Corridors, Buffer Zones and Dispersal Areas in 2018.

We are following a five-year corridor restoration plan compiled before the project began, which included corridor scenarios developed in GIS using multiple variables. Our implementation approach has been bottom-up, taking time to educate and consult widely with communities to build consensus. Focus Group Discussions and a schools education program have been an integral component of the approach. The Committee are making good progress overall in the participatory Joint Land Use Planning phase across the three villages involved, and following evaluation of 270 farm parcels, are paying out \$750,000 in land compensation to households. Construction of Tanzania's first elephant underpass has also been completed. In this presentation, we will share our experiences, challenges, and lessons learned on this restoration initiative which can be a model and inspiration for other corridors around Tanzania and beyond.

## EAC Transboundary Wildlife Conservation Areas Network (055-PAC-BIO-GOV) - EAC, CMS and IUCN (15:30-17:30)

On the 24th of August 2021 the EAC's Transboundary Wildlife Conservation Areas Working Group validated a concept note for the establishment of an EAC Transboundary Wildlife Conservation Areas Network. This Network, which is modelled around the successful experience with the with the similar SADC Transfrontier Conservation Areas, is envisaged to function as an information exchange, learning and innovation network that will convene technical expertise from international and regional conservation partners and development partners. The goal will be to establish dynamic, inclusive network that will be set up to provide a platform for quick information exchange and to facilitate collaboration at all levels. It will support the work of the TBWCA Working Group by facilitating information exchange and providing technical support to the functions of the Working Group. The network is also intended to help the EAC Partner States catalyse technical partnerships and funding to support conservation activities in the priority transboundary landscapes including supporting local community initiative.

## The Role of Youth in Preventing wildlife crime in East Africa: WWF led (11:30-12:30)

The Lake Victoria Basin (LVB) endowed with biodiversity resources that underpin the delivery of services and benefits critical to economic growth and human wellbeing. Healthy biodiversity and ecosystems such as forests and wetlands have immense potential to support adaptation to climate change and are the foundation of sustainable livelihoods.

Despite the high importance associated with biodiversity in the LVB, the region is experiencing losses in biodiversity capital which attributed to a wide range of causes that include rapid human population growth, widespread poverty, the rapid expansion of human settlements and agriculture, biodiversity over-exploitation, environmental degradation and pollution, invasive species, wildfires, and climate change (Kenya NBSAP (2019-2030). There is a need to enhance awareness and conserve nature, safeguarding Africa's iconic biodiversity.
