

INTRODUCTION AND OBJECTIVES

- 1. The Convention on Migratory Species (CMS) Energy Task Force (ETF) was established in 2016 to work towards reconciling renewable energy developments with the conservation of migratory species.
- 2. The ETF facilitates the use of best-practice guidance and promotes concrete action on the ground by bringing together governments, MEAs, NGOs, energy producers, financial and investment institutions, and researchers.
- 3. Following on the approval of the ETF workplan 2021-2024, the 6th meeting of the ETF represents a unique opportunity to jointly revise its gaps, agree on the shared priorities and discuss the next steps towards our goal: a just transition to renewables that does not harm migratory species.
- 4. The meeting specific objectives are:
 - a) Share updates on the current implementation of the ETF Workplan
 - b) Understand how related renewable-energy coalitions interact with the work of the ETF & agree on thematic and sub-regional priorities
 - c) Promote and share new technical and operational guidance on the planning and deployment of renewable energy
 - d) Strengthen industry and cross sectoral cooperation within and outside ETF members and observers.
